AUBURN UNIVERSITY

Freshman Scholarships

Freshman Scholarships are awarded exclusively to incoming freshmen and are renewable for four years. Students accepted for admission must apply through the <u>Auburn University Scholarship Opportunity Manager (AUSOM)</u> to receive consideration for Freshman Scholarships. To ensure maximum consideration, it is imperative students are knowledgeable of the specific requirements associated with all scholarships awarded.

Spirit of Auburn Resident

Spirit of Auburn Scholarships are awarded among Alabama resident students from October to February, based on academic achievement as demonstrated by standardized test scores and high school GPA. These four year, renewable scholarships are awarded at three levels: Presidential, Founders, and University.

Students must complete the scholarship application through <u>AUSOM</u> by midnight CST on <u>February 10</u>, and have the minimum ACT or SAT score* and high school GPA requirements to receive consideration. Minimum test scores required for consideration at each level do not include the writing score.

Presidential Scholarship

- Requires a 33-36 ACT or 1440-1600 SAT score and a minimum 3.5 high school GPA for consideration.
- Awarded at tuition for four years.

Founders Scholarship

- Requires a 30-32 ACT or 1330-1430 SAT score and a minimum 3.5 high school GPA for consideration.
- Awarded at \$32,000 for four years (\$8,000 per year).

University Scholarship

- Requires a 28-29 ACT or 1250-1320 SAT score and a minimum 3.5 high school GPA for consideration.
- Awarded at \$16,000 over four years (\$4,000 per year).
 - *Students who elect to test after the December ACT and SAT test dates are advised Auburn University cannot guarantee scores will be received and processed by the scholarship application deadline.

UNIVERSITY OF ALABAMA

O ACADEMIC ELITE SCHOLARSHIPS FOR 2016-2017

To be considered for the Academic Elite Scholarships, a student must be accepted as a member of the University Fellows Experience. The student must maintain membership in the UFE to continue holding an Academic Elite Scholarship. Complete information on the UFE can be found on the University Fellows website.

There are typically eight to ten of these scholarships offered each year. The pool of eligible applicants ranges from

There are typically eight to ten of these scholarships offered each year. The pool of eligible applicants ranges from 900 to 1,000 students.

Academic Elite Scholarship recipients typically receive:

- \$8,500 per year for 4 years
- The value of tuition in-state or out-of-state for 4 years
- One year of on-campus housing at regular room rate* (based on assignment by Housing and Residential Communities)
- iPad

ELIGIBILITY FOR THE UNIVERSITY FELLOWS EXPERIENCE

A student with an ACT score of 32 or an SAT score of 1400 (critical reading and math scores only) and a high school GPA of 3.8 who is accepted into UA will be eligible to complete the University Fellows Experience application. Applicants must first complete the Honors College application, and then must complete the UFE application. A student eligible for the Honors College (ACT of 28 or SAT of 1250 and high school GPA of 3.5) may be nominated for consideration by a high school representative or a UA faculty member. The online nomination form (including the student's full contact information and letter of recommendation) must be completed by a high school representative or UA faculty member. The deadline for nominations is **December 1**.

In the UFE selection process, the candidate's academic, extracurricular, service, and leadership achievements will weigh more heavily than grades and test scores.

CAPSTONE SCHOLAR

A first-time freshman student who meets the **December 15** scholarship priority deadline, has a **27 ACT or 1210–1240 SAT score (critical reading and math scores only)** and at least a **3.5 cumulative GPA** will be selected as a Capstone Scholar and will receive **\$14,000 over four years (\$3,500 per year)**.

COLLEGIATE SCHOLAR

A first-time freshman student who meets the **December 15** scholarship priority deadline, has a **28 ACT or 1250–1280 SAT score (critical reading and math scores only)** and at least a **3.5 cumulative GPA** will be selected as a Collegiate Scholar and will receive **\$16,000 over four years (\$4,000 per year)**.

FOUNDATION IN EXCELLENCE SCHOLARSHIP

A first-time freshman student who meets the **December 15** scholarship priority deadline, has a **29** ACT or **1290–1320** SAT score (critical reading and math scores only) and at least a **3.5** cumulative GPA will be selected as a Foundation in Excellence Scholar and receive the value of **one-half tuition or \$20,340 over four years (\$5,085 per year)**.

PRESIDENTIAL SCHOLAR

^{*} Regular room rate is defined as the largest room option in a particular dorm. Example: Riverside, Lakeside and Ridgecrest have four-person suites. The cost associated with the four person suite would be the value of the housing scholarship in this circumstance. If you live in an alternative dorm where double room occupancy is the largest available option, then the cost associated with the double room would be the value of the housing scholarship.

A first-time freshman student who meets the **December 15** scholarship priority deadline, has a **30–36 ACT** or **1330–1600 SAT score** (**critical reading and math scores only**) and at least a **3.5 cumulative GPA** will be selected as a Presidential Scholar and will receive the **value of tuition or \$40,680 over four years (\$10,170 per year)** to be used towards undergraduate or graduate/law studies.**

*For scholarships awarded only by Undergraduate Admissions — If tuition is being paid by an outside source, the scholarship dollars may be used for other educational expenses (room, board, books, etc).

**Students graduating with remaining tuition scholarship semester(s) may utilize these monies only toward graduate/law school study at UA. To be eligible, students must enroll in graduate/law school during the first available semester after receiving an undergraduate degree. (More information)

NATIONAL ALUMNI ASSOCIATION CRIMSON SCHOLARSHIPS 2016-2017

Crimson Scholarships are the premier scholarships administered by the National Alumni Association. To be considered for Crimson Scholarships, an applicant must be a first-time freshman, have a minimum 3.8 cumulative GPA (4.0 scale), a minimum 32 ACT or 1400 SAT [critical reading and math scores only], and demonstrate extensive leadership. While not a requirement, we prefer an applicant is ranked in the top 2% of their high school graduating class. Only those first-time freshmen meeting the scholarship priority deadline of December 15 will be considered, and applicant must self-identify on the UA Application for Scholarships.

Crimson Scholarships typically pay:

- Value of in-state or out-of-state tuition for 4 years
- Plus an additional \$3,500 per year for 4 years
- \$300 book grant each year for 4 years
- iPad

Students from Madison County, Alabama, and the contiguous counties of Jackson, Limestone, Marshall, and Morgan, are given priority consideration for a Gowen or Steven Mitchell Crimson Scholarship and must submit a typed one-page narrative statement describing personal financial need.

FAUKNER STATE

Scholarships

Faulkner State Community College offers several types of scholarships to beginning freshmen students. The Scholarship Committee awards scholarships for proven performance in academics, leadership, athletics, cheerleading, and performing arts. Detailed information and applications for scholarships may be obtained through the Office of Financial Aid. Students applying for any type of scholarship must file the FAFSA in order to qualify for the scholarship award. Only citizens of the United States or resident aliens are eligible for Institutional Scholarships.

Academic Scholarships

High school valedictorians, salutatorians, National Merit finalists, and National Merit semifinalists may be offered scholarships to attend Faulkner State Community College. The Scholarship Committee actively recruits student scholars with a proven academic track record. The College fosters quality education and welcomes the opportunity to assist promising scholars, regardless of their chosen fields of study.

Students awarded academic scholarships are designated "Presidential Scholars."

Web Language for Presidential and Institutional Scholarships

Athletic Scholarships

Additional scholarships are offered each year to outstanding athletes. Faulkner State Community College has developed an impressive intercollegiate reputation over the past years and strives to maintain its lead in athletic programs.

Cheerleading Scholarships

Cheerleading and Mascot scholarships are awarded annually to students who exhibit outstanding cheerleading abilities and skills. The Faulkner State Community College Cheerleaders have been National Cheerleading Champions in 1989 and 1991 and continue to excel in this winning tradition.

Civic/Business Scholarships

Additional scholarships are provided to Faulkner State Community College students through funds donated by area merchants, businesses, civic groups, and other patrons of the College. The eligibility requirements for these scholarships vary and depend on student needs, skills, and other factors.

Dogwood Trail Pageant Scholarship

Faulkner State Community College provides two Presidential Scholarships to two graduating seniors who previously placed in the top ten of the Dogwood Trail Pageant. The two scholarship recipients must be graduating seniors who are identified by the Dogwood Trail Pageant Committee. The scholarship recipients must enroll in the Summer or Fall Semester following their graduation and complete the two years in consecutive terms excluding Summer Semester. The Dogwood Pageant Committee must notify FSCC's Financial Aid Office of the two scholarship recipients' names by April 1 following the pageant.

James D. Martindale Memorial Scholarship

The James D. Martindale Memorial Natural Science Scholarship is awarded in the spring of each year to a deserving science or science-related major; the recipient must be a rising FSCC sophomore. The scholarship pays tuition and fees for one academic year. The student's application will be reviewed and the scholarship will be awarded by the Division Chair of the Natural Science Division, the Martindale family (or their designee), and the FSCC Scholarship and Financial Aid Committee. This memorial scholarship is named in honor of James D. Martindale who was the first instructor and Division Chair of Faulkner State's Natural Science Department. The scholarship was established in January 2008 by the family, FSCC faculty and friends.

Fine and Performing Arts Scholarships

The Scholarship Committee offers scholarships to students who show potential in the fine and performing arts such as art, commercial art/computer graphics, music, theater, and photography.

Leadership Scholarships

Faulkner State Community College also recognizes the importance of demonstrated leadership in high school and its significance at the college level. Scholarships may be extended to students who have served as senior class presidents, presidents of student bodies or student councils, editors of newspapers, and other significant leadership positions.

Senior Adult Scholarship Program (60-Plus Students)

This scholarship program is granted to Alabama residents who are 60 years of age or older and who enroll for classes either part-time or full time for credit or audit. This program covers only tuition cost.

Alabama GI Dependents Scholarship Program

The Alabama Department of Veterans Affairs offers financial assistance to eligible dependents (child, stepchild, spouse or unremarried widow(er)) of disabled veterans (living or deceased) who were permanent civilian residents of Alabama prior to entry into military service. Special consideration is given to permanently and totally disabled veterans who are bona fide residents or were prior to their death. Other qualifying veterans' categories are former prisoners of war (POW), declared missing in action (MIA), and those who died in service.

Maximum educational benefits include free tuition, required textbooks and laboratory fees for four standard academic years or a prescribed technical course at any state-supported junior or community college, university or technical school. Noncredit courses are excluded.

Dependent children must file an application prior to age 26 (may be extended to age 30 in certain cases). A spouse or widow(er) does not

have a filing deadline or age limitation.

Types of Scholarships/Awards

- To qualify for a scholarship, award or grant, a student must be in the traditional program and classified as a traditional student. Adults who are classified as traditional students are not eligible for the scholarships, awards, or grants herein described.
- All supplemental materials (essays, letters of recommendation, etc.) should be submitted when making application for scholarships.
- o Full-time enrollment (at least 12 semester hours) is required for any scholarship.
- Students receiving a scholarship or award from Faulkner University whose financial aid packages exceed the
 direct cost of education (tuition, fees, room and board) will not receive a credit or a refund. In these cases, the
 amount of the scholarship or award from Faulkner will be adjusted to preclude the awarding of a credit or refund.
- *Unless otherwise noted, scholarship and award amounts are for one academic year.
- One half of the total amount will be awarded in the fall term, and the other half will be awarded in the spring semester.
- Unless otherwise noted, all scholarships are renewable upon meeting the continuation criteria for up to nine (9) semesters.
- o All students receiving scholarships or awards are required to apply for all federal and state aid available.

Students who have been accepted for admission to Faulkner will be considered for the following academic scholarships:

Dean's Scholarship

- Freshmen applicants only
- ACT scores of 21 22 (SAT of 1500 1580)
- Range: \$1000 \$3000 per year
- Higher awards given to students who are actively involved in school and community activities.
- Scholarship committee will begin evaluations in early March.

President's, Trustee's, and Founder's Scholarships

- Freshmen applicants only
- ACT scores of 23 and over (SAT of 1590 and over)
- Range: \$3500- full tuition.
- Competition for these scholarships will be done through on-campus interviews.

National Merit Finalist/Semi-Finalist Scholarship

- Freshmen applicants only
- Must be confirmed as a National Merit Finalist or Semi-Finalist and have listed Faulkner University as their first-choice university with the National Merit Corporation.
- Finalists will receive funding equal to full tuition, room, board, and mandatory fees when coordinated with state, federal, and institutional scholarships and awards.
- Semi-Finalists will receive funding equal to full tuition when coordinated with state, federal, and institutional scholarships and awards.

Phi Theta Kappa Scholarship

- May be awarded to Phi theta Kappa members that are in good standing.
- Must have at least 60 hours of transferrable college credit with at least a 3.25 GPA.
- Award amount: up to \$2500

Transfer Scholarship

- Transfer applicants only
- College GPA of 3.00 and over
- Range: \$1000 \$6000

Grants and Awards

In addition to the awards above, students will be considered for a variety of other grants. To qualify, students must complete the FAFSA (Free Application for Federal Student Aid). Priority will be given to those students completing the FAFSA by March 15.

The following awards and grants are awarded for one academic year. Renewal is contingent on completion of the FAFSA, current funding levels, and a continued demonstration of financial need and satisfactory academic progress.

University Grant

The university grant may be awarded in varying amounts to students who demonstrate financial need as evidenced by the results of the yearly FAFSA.

Priority Award

This \$500 non-need based award may be given to students who complete the filing of their FAFSA by March 15.

Church of Christ Award

This non-need based award of \$1000 per year will be given to applicants who are active members of the church of Christ. At least one recommendation letter from a minister or elder of the student's congregation is required.

Christian Camp Award

Students who receive awards from Faulkner representatives at various Christian summer camps may be granted a \$500 per year award.

Departmental Awards

Some scholarships are awarded by academic departments in addition to those awarded by Faulkner Student Financial Services. Contact your department to learn more about potential scholarship opportunities.

Christian College Employee Award

Must be a dependent child of a full-time employee of a Faulkner sister college participating in the reciprocal tuition discount program. This award is for up to 50% of tuition when coordinated with all federal, state, and other institutional grants.

Christian High School Award

Must be a graduate from a high school affiliated with the churches of Christ and a member of the National Christian School Association (NCSA). This award is for up to 25% of tuition when coordinated with all federal, state, and other institutional grants.

Missionary Children

Must be a child of a full time church of Christ missionary currently in a foreign field and supported by a U.S. church of Christ. This award is for up to 75% of tuition when coordinated with all federal, state, and other institutional grants.

Lads to Leaders/Leaderettes Award

Participants in the Lads to Leaders/Leaderettes program who submit scholarship applications by the published deadline each year will be considered for this award. The National Office of Lads to Leaders/Leaderettes will recommend students to Faulkner who then may be awarded a scholarship. Award amounts vary from \$250-\$3000 per year.

Pioneer Awards

First-time students who apply for admission before October 30 may be granted a one-time \$500 award. First-time students who apply for admission before December 1 may be granted a one-time \$250 award. First-time students who are accepted for admission within 6 weeks of their application date may be granted a one-time \$250 award.

Scouting Leadership Award:

This award may be available to new freshmen and new transfer students who have achieved these levels:

- Boy Scouts of America (BSA) Eagle Scout
- Venturing (Coed program part of BSA) Silver Award
- Sea Scouts (Coed program part of BSA) Quartermaster Award
- Girl Scouts of the USA Gold Award
- American Heritage Girls Stars and Stripes Award

Students interested in applying for this award:

- Must apply for admission and be accepted to Faulkner University by April 1 of incoming year.
- Must submit a completed scholarship application packet by April 1 of incoming year.

Completed packets consist of:

- Written proof of the Scouting level
- A one page essay entitled What Scouting Means To Me.
- Two letters of recommendation from a non-family member. One must be from a scout leader.

This award can be used toward general tuition or fees in the traditional program only. Awards range from \$1,000 to \$3,000 per year. Student must maintain at least a 3.0 GPA while at Faulkner.

Home School Award

This \$1000 non-need based award is available to students who graduated from a home-school program.

Dual Enrollment Award

This \$1000 non-need based award is available to students who have completed at least two semesters of dual enrollment at Faulkner.

River Region Award

Students from Montgomery, Elmore, and Autauga counties will be considered for the River Region Award which ranges from \$1000 per year to half tuition.

HARDING UNIVERSITY

Not all scholarships listed have funds available, and you CANNOT apply directly for these scholarships.

Rather, students applying for admission are automatically considered for most scholarships for which funds are still available. Information about new scholarships, scholarships requiring a separate application, and other sources of scholarship funds is available on the Office of Financial Aid Services' Web site, located at www.harding.edu/finaid, or by contacting the office at 501-279-4257.

National Merit Scholarship Awarded to incoming freshmen who are National Merit Semifinalists and have selected Harding University as their first-choice university with the National Merit Scholarship Corporation. The award amount is full tuition. National Merit finalists also receive the value of the technology fee and standard room and board.

Trustee Scholarship Awarded to a select group of incoming freshmen as determined by an admission interview. All applicants with a minimum composite score of 31 on ACT or 1360 combined math and critical reading on the SAT and high school GPA of 3.5 on a 4.0 scale are invited. The award amount is full tuition. Academic Achievement Scholarship Awarded to freshman applicants with a minimum high

school GPA of 3.0 and ACT composite score of 22 or higher or combined math/critical reading SAT score of 1020 or higher. Award amounts range from \$3,500 to \$11,000 per year.

Transfer Student Scholarship Awarded to transferring students (transferring 14 hours or more) with a minimum transfer GPA of 2.5 or greater. Award amounts range from \$1,500 to \$2,500.

The Federal TEACH Grant is aimed to benefit current and prospective teachers at the undergraduate and graduate level with an up-to-\$4,000-per-academic-year grant. Several conditions exist including the agreement to serve/promise to pay requirement.

Freshmen

The USA Board of Trustees Endowed Scholarship, developed on behalf of the USA Board of Trustees, was designed to provide funding to exceptionally qualified and highly motivated incoming USA Freshman scholars. One award is given each year to the incoming Freshman candidate with the highest ACT/SAT composite score and GPA combination (based on a 4.0 scale). This scholarship will be used to fund annual tuition, and is renewable for the first four years of the student's undergraduate study - provided the student maintains the minimum requirements. This scholarship will serve as a supplement to any other scholarship awarded in order to give further distinction to the USA Board of Trustees Scholar program. In the event that the total scholarships awarded to the student meets or exceeds the annual cost of tuition and/or the institutional maximum, proceeds from this award may be used for study abroad, research, and other programs which enhance the student's education.

Spring Hill College

Spring Hill Scholars

Full tuition and fees scholarship offered to five students per year. Requires a separate application, cover letter, leadership and service resume and on-campus interview. Limited to students with a 3.5+ GPA and 27+ ACT. Award is renewable for all four years and does replace all Spring Hill College aid offered.

Merit Based Awards

All students admitted to Spring Hill College will be automatically considered. Awards range up to \$28,000 each year and are renewable for eight semesters with satisfactory academic progress.

Foley Service Scholarships

Spring Hill College awards Service Scholarships through the Foley Community Service Center. The Foley Center places students at service program locations in the metropolitan Mobile area where they can serve others and learn about local community needs at the same time. The scholarship is valued at up to \$2,000 per academic year.

Alumni and Family

Zoghby-DeVaney Memorial Scholarship

Awarded to qualified student from Mobile or Baldwin County, AL. Student must have a grandparent, parent or sibling that is an alumnus or an older sibling currently attending Spring Hill College. Awards range from \$1,000 - \$5,000 per year and are renewable for all four years. Money is raised for scholarship through a golf tournament.

National Alumni Association Scholarship

Awarded to qualified student who has a parent or grandparent that is an alumnus of Spring Hill College. Awards range from \$1,000 - \$5,000 per year and are renewable for all four years.

Legacy Grant

Given to any student with an alumnus (grandparent, parent, sibling) in the family. It is a \$1,000 grant renewable for all four years.

Family Discount

Given to youngest of multiple siblings attending SHC at the same time. Award is 10% of tuition (\$2,905) and worked into to need-based aid if student demonstrates need. If twins are enrolling each twin receives \$1,453. If 3 or more students are attending, every sibling but the oldest gets \$2,905.

Alumni Chapter Scholarships

These scholarships are administered by the Office of Alumni Programs in conjunction with the Office of Admissions and range from \$1,000 to \$5,000.

Art, Incentive, and Regional

Visit Grant

Given to any incoming student that visits campus. Award is \$1,000 one-time only; not renewable.

Citizenship

Amounts varied between \$500 and \$3,000. Renewable for all four years.

In rewarding achievement in all areas of endeavor, Spring Hill College seeks to award students who will enrich our community of learners as they embody the high value we place on service and commitment to both academics and/or all other areas of endeavor. Special consideration will be given to students who demonstrate focused activity and effort and/or leadership that has impacted their classmates, schools, workplaces or communities. Consideration will also be given to applicants who have demonstrated resilience in the face of hardships, disability, difficult personal situations or other disadvantage.

Citizenship awards recognize students in any one or more of the following categories:

- Significant participation in community service, civic participation or any other extracurricular activities
- Work experience and entrepreneurship
- Resilience in the face of hardship or disadvantage
- Promoting equity and understanding
- Outstanding leadership
- Distinction in the arts, humanities or sciences

Fannie Motley

Given to an African-American student once every four years. Award is \$2,500 and is renewable for all four years.

Athletic Scholarships

Athletic scholarships are awarded through the athletic department. Spring Hill College is a candidacy year 2 member of NCAA Division II. MERIT SCHOLARSHIPS

Academic scholarships are awarded on the basis of GPA from high school and/or ACT or SAT national test scores (for SAT tests, combined Critical Reading and Math scores). No ACT or SAT residual score can be used to establish scholarship eligibility. In order to receive an offer of academic scholarship money, the following forms must be submitted to the Office of Admissions:

- 1. Completed application for Admissions
- 2. A three-year transcript from high school
- 3. National ACT or SAT test score (No residual scores)

Academic scholarships begin at the 2.25 GPA level and a 19 ACT (910 SAT; combined Critical Reading and Math scores). Anyone admitted to FHU on restriction will not be able to receive an academic scholarship their first year. These scholarships are awarded on a first-come, first-served basis. Preference will be given to those that submit their required forms early. Early awarding begins in August or September of the senior year of high school. First-time Freshmen and students who transfer fewer than 30 hours(not including dual enrolled, CLEP, or AP hours) must maintain at least a 2.75 cumulative GPA during the first academic year to maintain merit scholarship money. Scholarships are renewable each year for upperclassmen and students who transfer more than 30 hours or more provided the student maintains a 3.0 cumulative GPA, not including AP, IP, and CLEP credits. The student's college cumulative GPA is reviewed after each semester.

TRUSTEES' SCHOLARSHIP

The Trustees' Scholarship, which is our largest award, is \$8,750 each semester for a full-time student taking courses in the spring or fall semesters or \$500 per credit hour for courses taken during the summer semester or during two-week courses taken in January or August. The Trustees' Scholarship is awarded to incoming freshmen who have a minimum high school GPA of 3.75 or higher and have a minimum national ACT composite score of 30 (1330 SAT; Critical Reading and Math scores ONLY). The Trustees' scholarship will be applied up to 126 hours, provided the student maintains a 3.4 college cumulative GPA (not including AB, IB, and CLEP credits) that is reviewed at the end of every semester. The required forms (application for Admissions, 3-year transcript, and ACT/SAT test scores) must be submitted to the Office of Admissions. Students receiving this award must live in university housing or a lesser award will be given.

NATIONAL MERIT FINALISTS

Students receiving this honor will receive the Trustees' scholarship. To receive this scholarship please send your official report to the Office of Admissions by March 1st. Students awarded this scholarship will maintain a 3.4 cumulative GPA (not including AB, IB, and CLEP credits) that will be reviewed at the end of every semester. Students receiving this award must also live in university housing or a lesser award will be given. National Merit Semi Finalist will receive special consideration for the highest general academic scholarship.

ENDOWED SCHOLARSHIPS

Endowed scholarships are available and awards are given based on criteria designated by the donor. All students are automatically considered for Endowed Scholarships. There is not an additional application process for these scholarships. Endowed Scholarships' purpose is to support merit awards and do not stack on top of merit awards. Amounts and recipients of these awards will not necessarily be the same from year to year. Some of the endowed scholarships are need-based as well. The Office of Student Financial Services will match students to endowed awards based on the criteria specified by the donor. To be eligible for the Endowed Scholarships, the <u>FAFSA</u> must be completed.

LADS TO LEADERS/LEADERETTES SCHOLARSHIPS

The Office of Financial Aid receives the list of possible recipients from Lads to Leaders headquarters usually in the spring semester of the students that have completed the Lads to Leaders Scholarship Application and have listed FHU as a top choice of college. The university will award the scholarship and notify the student of the award when they receive his/her financial aid award package. Financial aid award packages are sent out once the FAFSA is filed online at www.fafsa.ed.gov. Students must maintain a 2.5 GPA and it will be renewed at the end of every spring semester. Recipients must be enrolled full-time.

FHU ASSOCIATES ENDOWED SCHOLARSHIP

The Freed-Hardeman Associates is a women's organization designed to support and encourage Christian education at Freed-Hardeman University. As an endowed Scholarship, the FHU Associates' Scholarship's purpose is to support Merit Awards, so this scholarship does not stack on top of the Merit Awards. To apply for this scholarship an application needs to be completed. Please download and complete the application: <u>Associates Endowed Scholarship Application & Criteria</u>.

OUTSIDE SCHOLARSHIPS

There are several outside scholarships out there that you can apply for. Outside scholarship checks and notification should be mailed to the Office of Financial Aid. Scholarship links listed on the <u>Financial Aid Links page</u> are from scholarships that we have researched and some that our students have received in the past.

DISCOUNTS

In addition to scholarships, the following two discounts are available from the University: K-12 Christian School Faculty/Staff Discount, and Christian College Faculty/Staff Discount. All discounts are limited to 126 hours of course work.

A tuition discount of \$2,500 per full-time semester is awarded to dependent children of full-time employees of any K-12 Christian school associated with the churches of Christ. This, along with other institutional aid cannot exceed \$8,750 per semester. The tuition discount is \$120 per credit hour for summer courses and two-week courses offered in August and January. The K-12 Christian School Faculty/Staff Discount is capped at 126 credit hours. The <a href="https://christian.christ

Christian College Discount - A tuition discount \$5,000 per full-time semester is awarded to dependent students whose parents are full-time employees of the following Christian Universities: Abilene Christian University, Lipscomb University, Faulkner University, Harding University, Lubbock Christian University, Oklahoma Christian University, Ohio Valley University, and Pepperdine University. Parents must remain full-time employees for the student to receive this discount. This, along with other institutional aid, cannot exceed \$8,750 per semester. The tuition discount is \$240 per credit hour for summer courses and two-week courses offered in August and January. The Christian College Discount is capped at 126 credit hours. The Christian School Discount Form must be completed and signed by the Administration of the college, certifying that the parent is a full-time employee. The deadline for this form is July 1.

Christian Ministers Discount - Awarded to selected full-time, first-time students (minimum of 12 hours) who are children of full-time Church of Christ pulpit or youth ministers. Full-time means a 40 hour per week paid position. Excludes those that are "vocational" ministers. Ministers must have been employed full-time as a minister at least five years prior to receiving the discount. The Christian Ministers Discount Form must be completed and signed by two elders of the respective congregation. The form must be submitted to the Office of Student Financial Services by July 1. Effective Fall 2015, new undergraduate (freshman or transfer, age 23 and younger) students will receive up to a \$2,500 tuition discount per semester. Since FHU has no added fees as do other Christian universities, the discount may be combined with an academic scholarship but may not exceed \$8,750 per semester. The student must live oncampus, meaning they live in University housing and participate in a meal plan. Graduate students are not eligible.

FHU CHURCH MATCH SCHOLARSHIP PROGRAM

The <u>FHU Church Scholarship Match Program</u> will match any scholarship awarded by a church of Christ to an incoming freshman or transfer student for the 2016 spring semester or the 2016 - 2017 academic year, up to a total of \$2,500 a year.

To be eligible for this award, the student must meet the following criteria:

- Be admitted to FHU as a new full-time, residential incoming freshman or transfer student on the Henderson campus for spring or fall 2016.
- Enroll in an undergraduate degree program.
- Complete the Free Application for Federal Student Aid (FAFSA), available at <u>www.fafsa.gov</u>, and have the
 results sent to FHU. If selected for Verification, the student must submit all required documents to the Student
 Financial Aid Office.
- The church scholarship must be awarded for the spring 2016 semester or the 2016 2017 academic year.

This award is applicable only to the comprehensive charge (\$21,500 for 2016-2017). If a combination of this award and any other scholarship or discount exceeds the cost of the comprehensive charge at FHU (Henderson), this award may be reduced or cancelled. The maximum amount that a student can receive in the FHU Church Scholarship Match Award is \$2,500. If a student receives more than \$2,500 in church scholarships, the FHU Church Scholarship Match Award will not exceed \$2,500.

This matching award is renewable for up to four years, and is subject to review and adjustment by the Office of Financial Aid each year. The student must continue to receive a church scholarship equal to or greater than the matching award, take at least 12 hours each semester and maintain at least a 2.75 cumulative GPA during the first academic year, and at least a 3.0 cumulative GPA each year thereafter.

FHU PROMISE

The <u>FHU Promise</u> program guarantees that, beginning Spring of 2016, qualified, first-time freshman and transfer students will not have to take out more that \$9,500 in student loans per year. We will cover 100% of any financial aid gap for qualified, new students who are eligible for the PELL Grant.

LIPSCOMB UNVERSITY

First-time Freshmen

These scholarships apply to incoming Fall 2015 freshmen only.

The student's highest ACT/SAT score determines which academic scholarships they are eligible to receive. Additional ACT/SAT scores will not be used for scholarship determination beyond the first day of class in the student's freshman year.

Lipscomb Scholarship for national merit finalist

Each academic year, students who were selected as National Merit Finalists by the National Merit Scholarship Corporation are selected to receive a Lipscomb scholarship covering tuition and the general student fee only (no books). Confirmation from the National Merit Scholarship Corporation is required. If you receive one of these scholarships, you must maintain a GPA of 3.25 or above. This scholarship, like all other institutional aid, follows the Lipscomb Direct Cost Policy: Non-institutional gift aid such as Title IV funds, state grants, and outside scholarships will be applied to the student account first, and institutional aid is always applied last. This means that institutional aid will be adjusted to prevent over-awarding and cover only eligible charges as per scholarship requirements (i.e. books and other fees, such as global learning and nursing fees, will not be covered by the scholarship). Other non-institutional aid can be combined, but no other scholarships from Lipscomb. Recipients must live on campus and maintain a 3.25 cumulative GPA.

Lipscomb Scholarship for national merit semi-finalist

This annually renewable award is for students who were selected by the National Merit Corporation as National Merit Semi-Finalists will receive a full tuition scholarship. Confirmation from the National Merit Scholarship Corporation is required. If you receive one of these scholarships, you must maintain a GPA of 3.25 or above and live on campus. This scholarship is not stackable with any other institutional aid (except the Vision Award).

Lipscomb Scholarship for national achievement award (African American)

This award requires documentation from the National Merit Corporation. Finalists who live on-campus will receive \$3,000. Finalists who live off-campus will receive \$1,500. Semi-Finalists who live on-campus will receive \$2,000. Semi-Finalists who live off-campus students will receive \$1,000. The award may be stacked with all other gift aid, not to exceed full tuition. If all gift aid exceeds full tuition, the award will be adjusted to meet the awarding rule.

Lipscomb Scholarship for national Hispanic scholars

This award requires documentation from the National Merit Corporation. Finalists who live on-campus will receive \$3,000. Finalists who live off-campus will receive \$1,500. Semi-Finalists who live on-campus will receive \$2,000. Semi-Finalists who live off-campus students will receive \$1,000. The award may be stacked with all other gift aid, not to exceed full tuition. If all gift aid exceeds full tuition, the award will be adjusted to meet the awarding rule.

Trustee Scholarship

This prestigious full-tuition scholarship is awarded to five test-score eligible freshmen who are selected through an application and interview process. To be eligible to apply for this scholarship, you must have scored a 30 or higher on the ACT or 1320 or better on the SAT. If you receive this scholarship, you'll need to live on campus and maintain a GPA of 3.25 or above. This scholarship is not stackable with any other institutional aid (except the Vision Award).

Presidential Scholarship

Presidential Scholars are recognized for their outstanding academic achievements. Your application for admission will serve as your application for the Presidential Scholarship. Presidential Scholars will also be invited to attend Presidential Weekend, and will be awarded an additional \$1,500 study abroad scholarship at this special event. To be eligible to apply for this scholarship, you must have scored a 30 or higher on the ACT or 1320 or better on the SAT. If you receive this scholarship, you must maintain a GPA of 3.0 or above.

State Add-On Scholarships (for out-of-state residents only)

Out-of-state residents are awarded a renewable scholarship based on their ACT score. When entering Lipscomb with an ACT of 28 and above; the student receives a \$3,000 award. When entering Lipscomb with an ACT of 27 and below, the student receives a \$1,500 award. Any student receiving a state add-on scholarship **must live on campus** and maintain a cumulative 3.0 GPA. **Excludes:** Trustees, National Merit Finalist, National Merit Semi-Finalists, Lipscomb Academy Valedictorian Scholarship and athletes whose combined Lipscomb aid is full tuition and above.

Scout Award

Incoming Freshmen (only) who have received the Eagle Scout Award, Venturing Silver Award, Sea Scouting Quartermaster Award, GSUSA Gold Award, Ambassador Award, or American Heritage Girls Stars and Stripes Award are awarded \$2,500 per year. Proof of scouting award is required. Recipients must live on-campus and maintain a 3.0 GPA. The Scout Award is renewable up to maximum of eight semesters. Deadline for application is prior to freshman year enrollment.

Vision Award (first-time freshmen only; not available to transfer students; required to file FAFSA)

First-time Freshmen only, **entering fall 2010 and beyond,** who demonstrate strong leadership in their vision and determination to pursue a college education. Prospective students **who meet at least three** of the following criteria will be awarded an annual scholarship of \$1,000. To qualify, a student **must be a US citizen or Permanent Resident eligible to file a FAFSA.** This award requires a **cumulative 2.0 GPA** for renewal.

- Is the first generation in the family to attend college
- Has grown up in a single parent household
- Attended a public metropolitan high school
- Is a member * of a racial or ethnic minority group that is under-represented at Lipscomb University. (* At least one parent is considered a full minority)

Athletic Scholarship

Any athlete that receives \$12,000 or more in athletic scholarship is required to file a FAFSA (Free Application for Federal Student Aid).

International Student Scholarship

Incoming international students who are first time freshmen or first time transfers may be considered for an International Student Scholarship. Head of School Grant, formerly known as NCSA grant (Member School of National Christian School Association)
Student must graduate from an NCSA Member School (listed in current directory)

- a. \$5,000 award per year for on-campus students.
- b. \$2,500 award per year for off-campus students.
- c. Children of Lipscomb employees are not eligible for this scholarship.
- d. Recipients of Trustee, National Merit Finalists/Semi-Finalists, Lipscomb Academy Valedictorian Scholarship and Athletes whose combined Lipscomb aid is full tuition and above are not eligible.
- e. Awarded during packaging process, no application required.
- f. Cumulative GPA of 2.0 required for renewal.
- g. NCSA Grant in combination with all other gift aid may not exceed full tuition.
- h. Letter of recommendation required from the Headmaster of the NCSA school. Contact admissions for letter requirements.

Employment-Based Scholarships for Children of Ministers in the Church of Christ

Lipscomb University offers scholarships to undergraduate students whose parent is employed full-time (self-employed/paid minister as defined by the IRS in Publication 517 and working at least 40 hours per week) in certain ministerial positions that are associated with the Church of Christ. Students must maintain a 2.0 cumulative Lipscomb GPA, **live on campus** each semester, enroll full time (12+ hours) each semester, file a FAFSA each year, and provide employment verification annually to the Lipscomb financial aid office.

These awards are available to children who are less than 25 years of age and are considered dependent for federal income tax purposes. Married children are not eligible. Students must be seeking a first degree—second degree students are not eligible. These awards are subject to all GPA and probation restrictions as described in the Lipscomb Undergraduate Catalog and are available only for the customary duration of an academic program. The scholarships are available to children whose parents are employed in the following full-time roles:

- · Church of Christ minister
- Church of Christ youth minister
- Church of Christ missionaries—must be living full time in a foreign country, working at least 40 hours per week

There are two scholarship levels: \$11,000 per year (limited to 15 students. Priority is given to students who have been admitted to the university and have returned a completed employment verification form to the financial aid office by March 1 each year) and \$5,000 per year (awarded to all other students). These scholarships can be stacked with other gift aid, not to exceed the cost of full-tuition. If all gift aid exceeds full tuition, the grant will be reduced to meet the awarding rule.

Employment-Based Scholarship for National Christian School Association (K-12)

Scholarships of \$1,000 are awarded to students whose parent is employed full-time (40 hours per week) by a member school of the National Christian School Association (K-12). This grant is available to students who are enrolled full-time in Undergraduate studies, who are less than 25 years old, and who are considered dependent for federal income tax purposes. Married children are not eligible. Students must be seeking a first degree; second degree students are not eligible. This grant is subject to GPA and probation restrictions as described in the current Undergraduate Catalog and is available only for the customary duration of an academic program. Students must maintain a cumulative GPA of 2.0. This grant may be stacked with all other gift aid, not to exceed full tuition. If all gift aid exceeds full tuition, the grant will be reduced to meet the awarding rule. Children of Lipscomb employees are not eligible. Recipients of the Trustee Scholarship, National Merit Finalists/Semi-Finalist Scholarship, Lipscomb Academy Valedictorian Scholarship and Athletes whose combined Lipscomb aid is full tuition and above are not eligible.

Students are required to enroll as a full-time student (12 or more hours) and file a FAFSA (Free Application for Federal Student Aid) each academic year.

Application for NCSA (K-12) Scholarship

Employment-Based Scholarship for National Christian School Association (University Level)

Students who have a parent working full-time (40 hours per week) at a member school of the National Christian School Association at the university level can receive a 50% tuition grant. This grant is available to students who are enrolled full-time in Undergraduate studies, who are less than 25 years old, and who are considered dependent for federal income tax purposes. Married children are not eligible. Students must be seeking a first degree; second degree students are not eligible. This grant is subject to GPA and probation restrictions as described in the Undergraduate catalog. The grant, in combination with all other institutional aid, may not exceed 50% of tuition. The student account will be adjusted to meet the awarding rule. If institutional aid is higher, the student may choose to forfeit the grant. Children of Lipscomb employees are not eligible. The student must maintain a 2.0 GPA, live on campus each semester, be enrolled full time (12+ hours), file a FAFSA each year, and provide employment verification annually to the Financial Aid Office.

Church Match Program

Lipscomb University will match any amount up to \$500 (per year) that a Church of Christ contributes to a first-time freshman's education at Lipscomb.

CCCU (Counsel of Christian Colleges and Universities) Tuition Exchange Program

Lipscomb participates in the CCCU Tuition Exchange Program. For more information and an application, please visit <u>the CCCU website for more information</u>. Mail all applications to Lipscomb University, directed to the attention of Tiffany Summers.

Department Scholarships

- Art Department Scholarship: Amount varies, application and portfolio due by mid-March. Application details are online at <u>art.lipscomb.edu</u>.
- Religious Service Scholarship: Amount varies. Not typically awarded to freshmen. Application details are online at <u>bible.lipscomb.edu</u>.
- Engineering Scholarship: Amount varies, deadline is mid-March, Requires two recommendations and a personal statement as well. Application is available online.
- Music Scholarship: Amounts up to \$1,000 per semester. To be eligible, applicants must pass grade eight exam of the Associated Board of the Royal Schools of Music and provide documentation.
- Music Audition Scholarship: Amounts up to \$3,000 per semester. Apply and schedule an audition at music.lipscomb.edu. Last auditions are late February each year.
- Acting Scholarship: For acting and general theatre auditions, please prepare two contrasting 60 second monologues. No vocal

Financial aid award packaging is based on current information. Changes to the FAFSA, moving off-campus and additional gift aid (Lipscomb scholarships, outside scholarships, state and/or federal grants) may result in adjustment of institutional aid, including memorial scholarship awards.

Continuing Students

Lipscomb students can renew the scholarships they receive at entry. However, superior academic performance at Lipscomb does not allow for an increase in the award. You must retain a cumulative 3.0 to renew your scholarships. All Lipscomb University academic scholarships are valid up to 126 attempted hours. From time to time, exceptions to the 126 hour rule will be made for students who have unusual or extenuating circumstances, so students will need to contact the financial aid office when they approach 126 hours.

Regular Undergraduate students who do not enter with an Academic Scholarship may be awarded according to the transfer scale after earning at least 24 hours at Lipscomb. When aid has been lost due to cumulative GPA and/or other probation issues, it can be reinstated once the student raises their GPA or resolves their probation issues.

**Lipscomb's <u>Direct Cost Policy</u> could result in a change in scholarship amount for some students. Please review our policy and contact the Financial Aid Office with any questions.
